PGVCL is pleased to empanel you under Category: Empanelment registration number is **SRT20-21-PG-A-310**, as per the terms and conditions of the EOI and as agreed by you for Design, Supply, Installation, testing & Commissioning of Grid connected Rooftop Solar Photovoltaic Systems in Residential premises including five years comprehensive maintenance in the State of Gujarat for the Year 2020-21. You have to carry out the work at approved rate (inclusive of all) as under:

Terms and Conditions:

1. The above rates are for each of the SPV systems capacities and ranges inclusive of total system cost including Photo-Voltaic solar modules, inverters, balance of systems including cables, Switches/Circuit Breakers /Connectors/ Junction Boxes, mounting structure, earthing, Lightning arrester, local connectivity cost for cable & related other cost, cost of civil works, foundations etc. and its installation, commissioning, transportation, insurance, capital cost of online monitoring, comprehensive maintenance charges for five years, applicable fees and taxes etc., including GST and all applicable taxes & duties.

The rates are on F.O.R. destination at consumers premises basis, Price is inclusive of taxes, levies, duties, packing, forwarding, freight, insurance, loading unloading, supply, installation, commissioning, 5 years CMC Charges etc. and any/ all charges for successful Supply and Installation of the systems at any locations in the State of Gujarat and all other miscellaneous expenses of marketing, commissions etc. if any.

The rates are inclusive of GST, Work Contract Tax, welfare cess any other taxes applicable to such work. Any escalation in such taxes/ levies during the tenure of the offer/ Empanelment will not be paid by consumers. **In no circumstances, escalation in the prices will be entertained.**

2. The applicable fees, charges for connectivity, bi-directional Net-meter, meter testing, smc box etc. Shall be borne by Consumer and shall be paid separately to the concerned DISCOM by the consumer.

3. Project Registration with DISCOM:

Consumer can submit the application to sub-division of DISCOM directly instead of to Agency. Consumer has required to mention the name of Agency selected by him/her in the prescribed application form. Empanelment No., signature with Stamp of the selected Agency and the consumer -Applicant's signature are required in the Application form. Prescribed Application Form will be made available on DISCOM's website and SURYA-Gujarat Portal.

Applicant-consumer as well as Empanelled Agency on behalf of consumer may also be allowed to upload his/ her application on portal with application fee payment over and above the facility of submission of applications at Subdivision. However, time to time it may be reviewed.

4. In case of non-payment of this Estimate within one month of the issue of Estimate (Firm quotation-FQ), the application for SPV System will be cancelled.

5. **Project Time schedule: -**

Project time schedule for completion of solar system installation work will be increased from 60 days to 85 days from date of payment of Firm quotation charges. In case of a representation receive from the consumer regarding delay in making payment to the agency due to some genuine reasons. In that case the time limit will be reviewed on case to case basis for such consumers only.

In the event of failure to install the SPV Systems , DISCOMs will lead to forfeiture of the Security deposit and performance guarantee up to 100% and will lead to disqualification of the Bidders for transacting business with DISCOMS for at least three years or the time duration as may be decided by the Concern DISCOM /GUVNL.

The work for Installation of the SPV System shall be considered as completed if the SPV System is installed completely in all aspects including the submission of all required documents, self-certification/CEI certificate on portal and PPA duly signed. The Agency shall require to intimate for the work completion date on portal.
